Experience Highlights

Union Music Ltd –v- Russell Watson

- Harvey was instructed by Union Music in a claim against the Opera singer Russell Watson in relation to his Management Agreement. He successfully defended an appeal to the Court of Appeal of a decision to refuse Mr Watson's application to strike out the case against him on an argument of a Contract being voidable.
